To what extent were the environmental and/or social characteristics promoted by this financial product met?

The Sub-Fund promotes both environmental and social characteristics by investing in real estate properties in the assisted living segment, by integrating the GPR-method in the investment decision process and by taking principle adverse impacts into account.

The investment strategy of the Sub-Fund aims to improve the energy performance of the real estate properties and aims to reduce the energy and water consumption and the greenhouse gas emissions.

Next to the environmental characteristics, the Sub-Fund promotes social characteristics by investing in affordable and sustainable healthcare housing and facilities. The Sub-Fund invests in principle in healthcare properties that are categorised in the affordable and/or

mid-market rental segment. Furthermore, it invests only in in real estate that falls within the assisted living segment. The assisted living segment is defined by properties that have a residential real estate character with a healthcare and/or well-being component and therefore the social characteristic adequate living standards and wellbeing for end-users and tenants are promoted.

The environmental and social characteristics were partly met. Although investments in renovation and installation of energy-saving measures have been made, no property meets the GPR target because of increasingly strict GPR guidelines. Nonetheless, the portfolio contains no energy-inefficient real estate assets. The share of investments in the affordable and/or mid-market segment remains very high. The GHG emissions and energy consumption decreased as a result of the investments in energy-saving measures. Water consumption remained approximately the same.






